



Instrumental Music Lessons – 2017/18

The school has to book its peripatetic teachers for the next academic year and is pleased to offer pupils the opportunity to **either start learning an instrument or to continue with lessons**. Music makes a valuable contribution to the life of our school and we are fortunate in having an excellent team of dedicated teachers offering weekly tuition in the following wide range of instruments:

Brass (cornet, trumpet, trombone, French horn, euphonium),

Woodwind (flute, oboe, clarinet, saxophone)

Guitar (acoustic)

Keyboard

Recorder

Violin

Piano

Percussion (drum kit)

For the academic year 2017/18 the cost of the lessons is as follows:

Individual 20 minute lessons	£148.50	per term
Groups of 3 or 4 - 30 minute lessons	£77.00	per term

Please note that piano/keyboard and violin can only be booked as an individual lesson (i.e. no group lessons are available). Flute and clarinet can only be offered to children in Year 5 and Year 6. Please contact the school should you require information on buying/hiring musical instruments. Please do not hire/buy musical instruments before you have contacted the school/music teacher.

Please be aware that the school has to book blocks of tutor time with the Area Music Centre. Although we operate a rotation system (within those blocks), your child's music lesson could frequently take place during the daily English and Maths lessons.

Further terms and conditions including the Remission of Fees are shown overleaf.

If you are interested in your child beginning or continuing lessons, please complete the attached form and return with the money (cheques should be made payable to The Thomas Coram CE School) **by Friday 9 June 2017** so that arrangements for September can be finalised. Please be aware that lessons are not guaranteed and that your cheque may be returned.



Music Tuition Terms and Conditions 2017/18

1. Payment

Autumn term – payment with application form. Cheques made payable to The Thomas Coram CE School and will be banked in July.

Spring and Summer term – payment on receipt of invoice can be made by cheque or through Wisepay (the school's on-line payment service). Invoices are usually raised at least 4 weeks in advance.

Music fees will change during the academic year 2017/18 **only** if the Herts Music Service revises its charges to schools.

2. Number of lessons

The fees are for a **minimum** of 30 lessons and a maximum of 33 per academic year, payable in advance and any lessons missed by pupils through no fault of the school will be forfeited.

3. Children will be expected to remember the importance of arriving at lessons on time and fully equipped. Although the school may initially support pupils, it is your child's responsibility to ensure they check the music lesson timetables and attend the scheduled lessons each week.

4. Remission of Fees

Hertfordshire County Council runs a scheme for the remission of music fees for parents facing financial difficulties.

Remission funding will not be backdated. Lessons that begin **before** the Music Service confirms remission funding to the school, will be charged to the parent/carer.

There is a charge of £20.00 per term for those families applying for 100% remission of fees. An individual 20 minute lesson is the maximum lesson available under this scheme.

There are strict deadlines by when applications must be made and if you would like to clarify your eligibility or to be considered, please indicate on the attached application form **and** contact Children's Services at www.hertfordshire.gov.uk or telephone 0300 1234048.

There is an expectation that pupils in receipt of remission of fees will attend regularly and the school sends a copy of the attendance register to the Herts Music Service at the end of each term. Pupils who have a poor attendance record may have their remission of fees cancelled.

5. Termination of music lessons

The school is required to give our peripatetic teachers notice of changes to their contracts and, therefore, parents are asked to give the school written notice of cancellation by the dates shown below, or make a payment in lieu. **A letter will be sent to confirm cancellation and only then are the lessons cancelled.**

Spring Term 2018 cancellation by Monday 16 October 2017

Summer Term 2018 cancellation by Monday 5 February 2018

6. Insurance of Musical Instruments

Parents must ensure that their child's instrument is named and is adequately insured as they are brought onto school premises entirely at the owner's risk.

7. Please be aware that the school has to book blocks of tutor time with the Area Music Centre. Although we operate a rotation system (within those blocks), your child's music lesson could frequently take place during the daily English and Maths lessons.
